Eligible claimants:	Claims are only open to Victorian residents who are 18 years of age or over.
How to Claim:	To claim a gift, the claimant must complete the following steps during the Promotional Period: a) spend at least \$500 (inclusive of GST) on any goods in one (1) transaction via www.bowens.com.au; and b) where the purchase is made using a Bowens credit account, have an invoice issued for that purchase during the Promotional Period. Eligible claimants will then receive an email from the Promoter containing a Gift Redemption Form, which must be completed and submitted (including preferred hoodie size and delivery address) within 30 days of receiving the email. Only the first three hundred (300) valid claims redeemed will be awarded with the gift outlined below.
Claims permitted:	Multiple qualifying transactions are permitted subject to the following: a) maximum of one (1) claim permitted per qualifying transaction; b) maximum of one (1) redeemed gift permitted per person during the Promotional Period, regardless of the number of qualifying transactions completed; and c) each claim must be completed separately and in accordance with the claim instructions above.

Conditions of Claim

1. The claimant agrees and acknowledges that they have read these Conditions of Claim (and the Schedule) and that claiming a gift in the Promotion is deemed to be acceptance of these Conditions of Claim (and the Schedule). Any capitalised terms used in these Conditions of Claim have the meaning given in the Schedule, unless stated otherwise. Offer not valid in conjunction with any other offer.
2. The Promotion commences on the Start Date and ends on the End Date (“Promotional Period”). Claims are deemed to be received at the time of receipt by the Promoter and not at the time of transmission or deposit by the claimant. Records of the Promoter and its agencies are final and conclusive as to the time of receipt.

3. Valid and eligible claims will be accepted during the Promotional Period, while gift stocks last. Only the first three hundred (300) valid claims redeemed in accordance with these Conditions of Claim will be awarded a gift.
4. Employees (and their immediate family members) of the agencies/companies directly associated with the conduct of this Promotion, the Promoter, businesses involved in determination of successful claimants for the Promotion, businesses involved in the management of the Promotion, any organisation benefiting from the Promotion, the Promoter's distributors, suppliers, subsidiary companies/businesses and associated companies and agencies are not eligible to claim. "Immediate family member" means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
5. Eligible claimants will be identified by the Promoter based on qualifying completed transactions and/or issued invoices (as applicable) and will receive an email from the Promoter containing a Gift Redemption Form. To redeem the gift, the claimant must complete and submit the Gift Redemption Form, including their preferred hoodie size and delivery address, within fourteen (14) days of receiving that email. Claims not redeemed within this period will be forfeited and no substitute will be offered.
6. The minimum spend threshold of \$500 (inclusive of GST) must be achieved in a single transaction after all discounts are applied, and excludes delivery fees, gift cards, refunds, returns and cancelled orders.
7. If a qualifying transaction is refunded, cancelled, returned or otherwise adjusted such that the transaction no longer meets the minimum spend requirement, the claimant may become ineligible for the gift and the Promoter reserves the right to withhold delivery of the gift or require its return.
8. The gift will be dispatched to the delivery address supplied in the Gift Redemption Form within a reasonable period following verification of eligibility and receipt of the completed form. The Promoter accepts no responsibility for delivery information that is incorrectly supplied by the claimant.
9. The value of the gifts is accurate and based upon the recommended retail value of the gifts (inclusive of GST) at the date of printing. The Promoter accepts no responsibility for any variation in the value of the gifts after that date.
10. No part of a gift is exchangeable, redeemable for cash or any other gift or transferable, unless otherwise specified in writing by the Promoter. The Promoter reserves the right to substitute the gift (or any element of it) with an alternative item of equal or greater value if the gift becomes unavailable for any reason, subject to State or Territory regulation.
11. Each gift will be awarded to the person named in the claim and any claim that is made on behalf of a claimant or by a third party will be invalid. If there is a dispute as to the identity of a claimant, the Promoter reserves the right, in its sole discretion, to determine the identity of the claimant.
12. Claimants' personal information will be collected by the Promoter directly or through the Promoter's agents or contractors. Personal information will be stored on the Promoter's database. The Promoter collects personal information about claimants to enable them to participate in this Promotion and may disclose the claimants' personal information to its related entities and third parties including its contractors and agents, gift suppliers and service providers to assist in conducting this Promotion. By submitting a claim, claimants consent to receive email or SMS messages from the Promoter without any functional unsubscribe facility if they relate primarily to the conduct of this Promotion. If the claimant does not provide their personal information as requested, they may be ineligible to claim a gift in the Promotion. Any guarantee or warranty given is in addition to any relevant statutory guarantees and warranties and nothing in these Conditions of Claim restricts, excludes or modifies or purports to restrict, exclude or modify any statutory consumer rights under any applicable law including the Competition and Consumer Act 2010 (Cth).
14. If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected claims, or suspend or modify a gift, subject to State or Territory regulation.

15. The Promoter reserves the right, at any time, to validate and check the authenticity of claims and claimant's details (including a claimant's identity, age and place of residence). If a claimant cannot provide suitable proof as required by the Promoter to validate their claim, the claimant will forfeit the gift in whole and no substitute will be offered.
16. The Promoter reserves the right to disqualify claims in the event of non-compliance with these Conditions of Claim, or where a claimant tampers with the claim process or submits information that is misleading or fraudulent. If there is a dispute concerning the conduct of the Promotion or claiming a gift, the Promoter will resolve the dispute in direct consultation with the claimant. If the dispute cannot be resolved the Promoter's decision, acting reasonably, will be final.
17. The Promoter and its associated agencies and companies will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence or wilful misconduct) in connection with this Promotion or accepting or using any gift (or recommendation). For the sake of clarity, this clause shall not apply where the Promoter has contributed to or caused such loss, expense, damage, personal injury or death and shall not apply to any liability which cannot be excluded by law (in each case the Promoter's liability is limited to the minimum allowable by law).
18. The claimant(s) will participate in and co-operate as required with all reasonable marketing and editorial activities relating to the Promotion, including (but not limited to) being recorded, photographed, filmed or interviewed and acknowledges that the Promoter may use any such marketing and editorial material without further reference or compensation to them.
19. The Promoter accepts no responsibility for any tax implications and the claimant must seek their own independent financial advice in regards to the tax implications relating to the gift or acceptance of the gift.
20. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of these rights.
